Scope

Goals

- Reduce administrative code redundancy through consolidation
- Update administrative procedures for waterway regulations to align with statutory requirements
- Update fee system

Wetland Exemptions (300.05)

- Creates general sideboards for exemption decisions
- Incorporates Act 183 components
 - Specifies process for voluntary exemption reviews vs. mandatory exemption reviews
- Affirms DNR's intention to be consistent with federal exemption policies to the greatest extent possible

Wetland Identification Requests

General Information

Complete all sections, **Save** your work, **Move** between tabs, **Pay** online by credit card, debit card or e-check. (You must use this system to pay all application fees), **Include** your digital signature, **Submit** the Application to the DNR.

NOTE: Missing or incomplete fields are highlighted at the bottom of each page. You may save, close and return to your draft permit as often as necessary to complete your application. If there are **no** updates in 90 days, your draft is **deleted**.

Waterway and Wetland GPs (300.06)

- Specifies application submittal requirements
- General eligibility determination sideboards
- Wetland self-reporting permits
 - Clarifies statutory authority in s. 281.36(3g)(h)4, ability for DNR to waive permit application process
 - Creates standards for DNR to use wetland self-reporting GPs authorization

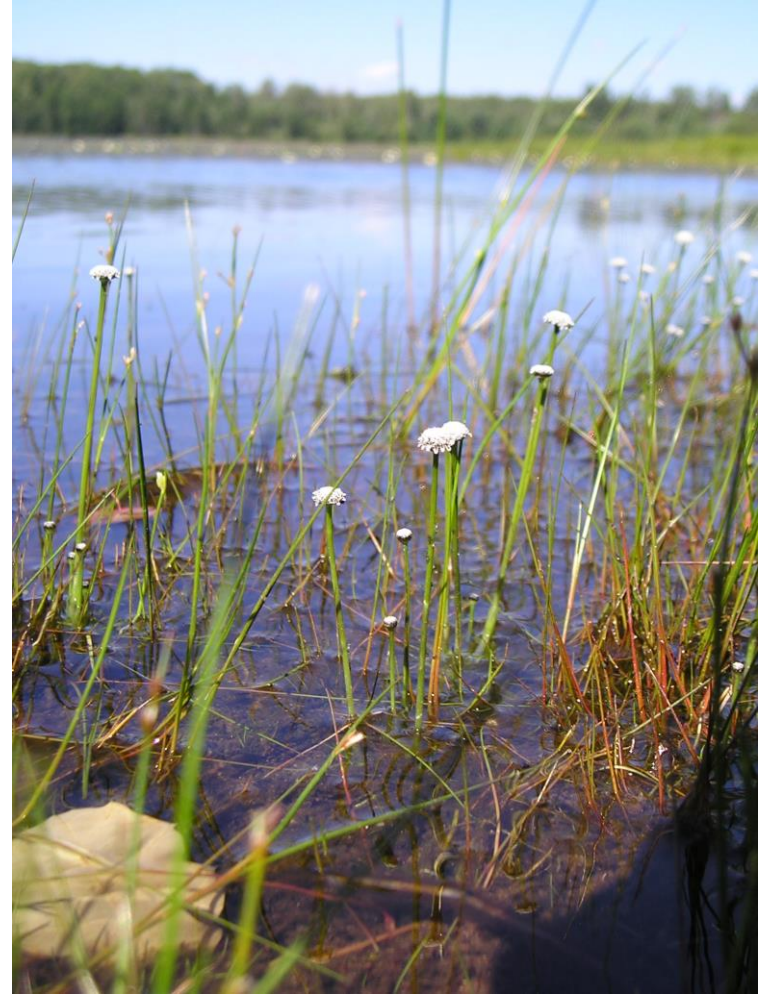
GENERAL PERMIT AUTHORIZATIONS: In compliance with the provision(s) of section 281.36 (3b)(b), Wis. Stats., no person may discharge/place dredged or fill material into a wetland unless the discharge is authorized by a wetland general permit or individual permit issued by the Department of Natural Resources (Department) or the discharge is exempt under s. 281.36(4). The Department has authority to issue general permits under s. 281.36(3g), Wis. Stats.

Notices and Public Comment (300.08)

- Significant reduction in duplicative content
- Creates opportunity for virtual hearings, must meet the following conditions:
 1. The applicant and any interested member of the public that requested the public informational hearing agree to this hearing format.
 2. A telepresence hearing will provide for efficient and effective means to gather public comment and information.
 3. All hearing materials are readily available electronically.

Fees

- Current fees were enacted in 2011 Act 118
- Fee increases are necessary to account for inflation, travel costs, and application mitigation review and approval decisions in order to provide program funding for staffing

Water Quality Certification

- In September 2020, EPA and USACE updated 401 WQC regulations
- Elements that have changed as a result of federal rule changes:
 - Pre-application requirements
 - Application requirements
 - Increased coordination between USACE and WDNR
 - Downstream consultation requirements
- This rule is NOT intending to replicate federal rule changes or update NR 299
- This rule seeks to clarify and standardize the waiver process for exempt activities

Navigability and OHWM Determinations

- Optional service
- Creates standard process, timelines and expectations for DNR to complete a navigability or OHWM determination for a stakeholder
- For planning purposes outside permit and enforcement processes
- Does not impact surveyors or counties from also completing OHWM and navigability determinations



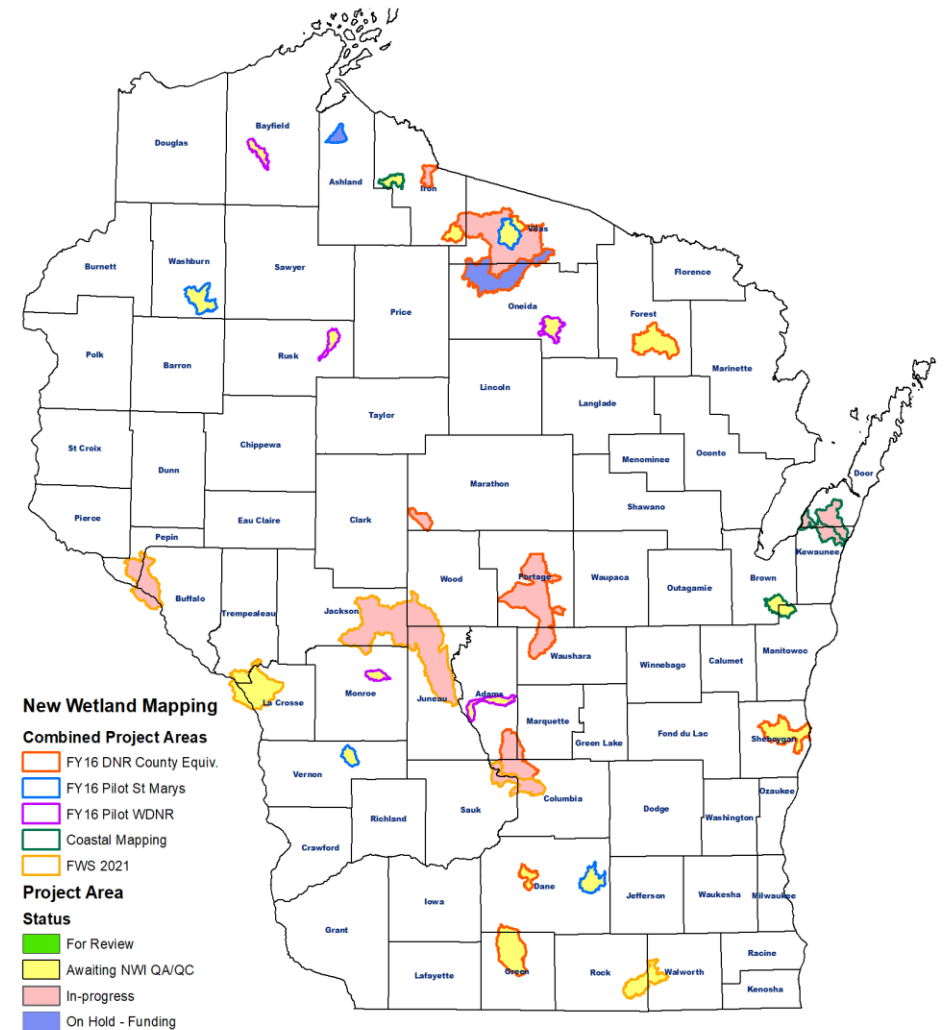
Service Options

- DNR completes
- DNR confirms
- MOAs may be negotiated with municipalities, the U.S. army corps of engineers, and other governmental entities

Wetland mapping

- Current fee structure in 23.32 is based on printed maps
- A person may request that a watershed be mapped
 - No smaller than a HUC-12 watershed size
 - Fee is \$0.10 per acre for the request
- DNR may enter into a MOA with another organization or entity to incorporate wetland mapping conducted by an independent third party
